Director Dyer indicated that only one Commissioner position had been approved in the bylaws, and that by a strict reading it would require the Commission to approve an interpretation allowing additional Commission members to serve. Commission waited to discuss the matter at the December meeting pending further interest from the public.

Tabled to allow for more time to look into PA system and evacuation announcement systems. Looking to use the emergency notification system that the fairground already has, adding additional notification systems in areas to ensure consistent coverage. **Condition:** Speakers must be procured and installed on or before May 31, 2024, annual system training, can continue using current system in interim.

Occupiable spaces on lower level not open to floors with vertical opening to prevent exposure to smoke and hot gages in a fire event. Proponent notes that hardship is actually that denial of the variance would require an atrium smoke exhaust system that he feels is unnecessary to meet the intent of the code.

- vii. **23-10-34 Christ the King Catholic Church Narthex Addition (South Bend) – LFO** notes that the church is over 120k square feet and is opposed to the variance. Two fires in the last two years in areas that do not have fire suppression system. Seeking to not include a fire suppression system in new areas. 3 hour firewall separating proposed addition from the rest of the building. Mr. Rensink believes that rfirst exception for religious spaces under 7k feet and primarily used for worship apply, fire marshal disagrees based on number of seats. Commissioner Cook believes that the exception also applies. Chairman Murua believes that it does not due to being a gathering area not necessarily primarily used for worship. Christina Collester notes that the language included was meant to include the entirety of any building used primarily for worship, not individual spaces.
