Good morning Mr. Boyle,

I am writing to you to make the necessary revisions to the petition for review that was submitted on December 4, 2020. I have attached the inspection from the City of Bloomington Fire that is dated November 20, 2020 and would like the following remarks to be added to our submission.

Entity Issuing Order: City of Bloomington Fire Prevention Bureau

Explanation of being aggrieved or adversely affected by the order: Under the current circumstances of the COVID 19 pandemic, we feel that there should be an exception to CODE 3103.5 Use Period. As stated previously, the Monroe County Health Department has encouraged restaurants to use outdoor seating whenever possible to ensure that we are following theirs' and the Governors' social distancing guidelines.

What is your desired outcome?: Our desired outcome is that we would be able to keep the membrane structure erected so that we can continue business as a restaurant and be able to provide a great place for the residents of Bloomington and surrounding counties to eat. Also, that we would be able to give our employees a place to work. The membrane meets the inflammability guidelines of the state of California, it is wind rated up to 120mph gusts and is made of aluminum. We have already made the necessary changes by converting the heating system from the gas towers inside the tent to an exterior UL system designed for the safety of the tent. We have placed fire extinguishers and illuminated exit signs in the appropriate places. The capacity of the tent is limited to a maximum of 49 and is currently reduced to a seating capacity of 44 to meet the requirements of social distancing.
