Mr. Millner,

At its regularly scheduled meeting on Wednesday, June 2, 2021, the Fire Prevention Building Safety Commission (Commission) considered the Evansville Fire Department's request to impose sanction(s) on your variance, Variance No. 16-03-61, pursuant to the procedure afforded in its rules [see Section 11 of the Commission's currently-effective Emergency Rule – LSA Document #19-333(E): https://www.in.gov/dhs/files/LSA-Doc-19-333E.pdf]. Upon review, the Commission determined that you have not complied with the alternative requirements (conditions) contained in your variance and took explicit action to impose a sanction on your variance.

Pursuant to its authority under Indiana Code § 22-12-7-7, the Commission now serves on you this **LETTER OF REPRIMAND**, for your failure to comply with the alternative requirements (conditions) of your variance. In addition to serving on you this Letter of Reprimand, the Commission directs you to take the following actions:

- 1. You, as the owner, shall provide proof to the Commission that you have retained a contractor to perform the necessary work on the structure's sprinkler system within thirty (30) days of the date of service of this order.
- 2. You, as the owner, shall provide reasonable proof to the Commission that the necessary work is commencing or near completion within six (6) months of the date of service of this order.

Failure to complete these actions within the stipulated deadlines may result in the Commission taking additional action to impose an additional sanction on your variance, including, but not limited to, **REVOCATION** of your variance.

EFFECTIVE DATE

Pursuant to Indiana Code § 4-21.5-3-6, this order is effective fifteen (15) days after it is served, unless a petition for administrative review and a petition for stay of effectiveness are filed before the order becomes effective. If a petition for review is not timely filed, this order is final.

ADMINISTRATIVE REVIEW RIGHTS

If you desire administrative review of this order by the Commission, you must comply with the requirements of Indiana Code § 4-21.5-3-7 and file a written petition for review within 15 days of the date this order was served, however, this period is extended to 18 days if service is made by mail. Your petition for review must state facts demonstrating that you are: (1) a person to whom the order is specifically directed; (2) aggrieved or adversely affected by the order; or (3) entitled to review under any law. 

Dear Mr. Millner:

On February 1, 2021, members of the Evansville Fire Department's Fire Marshal Division conducted a fire inspection of the Garvin Business Center located at 1315 Read St in Evansville Indiana 47710. During this inspection the fire inspector observed the Automatic Sprinkler System had no current annual inspection and internal inspection since 2018. On February 23rd this facility was placed under mandatory fire watch due to an impairment on the automatic sprinkler system. These violate IDHS Commission Conditions of variance # 16-03-61 which required this facility to be in compliance with NFPA 13 Standard for the Installation of Sprinkler Systems. As a result of these violations and conditions observed during this inspection. The Garvin Business Center shall provide the following:

IFC 3204.2 Designation based on engineering analysis. The designation of a high-piled combustible storage area, or portion thereof, is allowed to be based on a lower hazard class than that of the highest class of commodity stored when a limited quantity of the higher hazard commodity has been demonstrated by engineering analysis to be adequately protected by the automatic sprinkler system provided. The engineering analysis shall consider the ability of the sprinkler system to deliver the higher density required by the higher hazard commodity. The higher density shall be based on the actual storage height of the pile or rack and the minimum allowable design area for sprinkler operation as set forth in the density/area figures provided in NFPA 13. The contiguous area occupied by the higher hazard commodity shall not exceed 120 square feet (11 m₂) and additional areas of higher hazard commodity shall be separated from other such areas by 25 feet (7620 mm) or more. The sprinkler system shall be capable of delivering the higher density over a minimum area of 900 square feet (84 m₂) for wet pipe systems and 1,200 square feet (111 m) for dry pipe systems. The shape of the design area shall be in accordance with Section 903.

The following actions shall be required to be in compliance with IFC 3204.2 & NFPA 13.

Designation based on engineering analysis shall be provided on all units of this facility. This shall be conducted by a design professional that can provide approved documentation that the automatic sprinkler system is designed for the products & commodities stored in this facility, and is in compliance with IFC Section 903 & NFPA 13.

You have ten (10) days from the date of this letter to comply with the City of Evansville's Fire Prevention Code, including its adoption of the International Fire Code (IFC) 2012 Edition, and the Indiana Fire Code Amendments, referenced in the above violations. Failure to comply will result in further action by EFD, including, but not limited to, the pursuit of up to \$2,500 in fines and penalties per violation per each day that the above violation(s) continue, as permitted by Fire Prevention Code § 8.20.090 and Evansville Municipal Code § 1.05.180.

- 7. Electrical outlet not secured unit J: IFC 605.1 Abatement of electrical hazards. Identified electrical hazards shall be abated. Electrical wiring, devices, appliances and other equipment that is modified or damaged and constitutes an electrical shock or fire hazard shall not be used.

During inspection high piled combustible storage and the storage of class 1 plastics were noted. With these items being stored in these units an engineering analysis is needed in accordance with IFC 3204.2



Dear Mr. Milner:

On October 17, 2018, members of the Evansville Fire Department's Fire Marshal Division conducted a follow up visit of the Garvin Business Center located at 1315 Read St in Evansville Indiana 47710. This visit was following up on a letter we received stating that the fire sprinkler system had been turned off (removed from service). This was verified during the site visit.

Also it was observed that this occupancy had a tenant that had manufacturing process set up which would be considered by code an F1 Occupancy. This was located in unit J, Staley Ventures.

Factory Industrial Group is defined as:

306.1 Factory Industrial Group F. Factory Industrial Group F occupancy includes, among others, the use of a building or structure, or a portion there of, for assembling, disassembling, fabricating, finishing, manufacturing, packaging, repair or processing operations that are not classified as a Group H hazardous or Group S storage occupancy.

During this site visit we observed machinery in place for grinding plastic materials (see photo).

These are in violation of Variance Number 16-03-61 issued by the Fire Prevention and Building Safety Commission on March 4, 2016.

The Following Fire Code Violations were also observed during this visit:

<u>901.4.5 Appearance of equipment</u>. Any device that has the physical appearance of life safety or fire protection equipment but that does not perform that life safety or fire protection function shall be prohibited.



<u>901.6 Inspection, testing and maintenance</u>. Fire detection, alarm, and extinguishing systems, mechanical smoke exhaust systems, and smoke and heat vents shall be maintained in an operative condition at all times, and shall be replaced or repaired where defective. Non required *fire* protection systems and equipment shall be inspected, tested and maintained or removed.

901.7 Systems out of service. Where a required fire protection system is out of service, the fire department and the fire code official shall be notified immediately and, the building shall either be evacuated or an approved fire watch shall be provided for all occupants left unprotected by the shutdown until the fire protection system has been returned to service.

Where utilized, fire watches shall be provided with at least one approved means for notification of the fire department and their only duty shall be to perform constant patrols of the protected premises and keep watch for fires.

901.8.1 Removal of or tampering with appurtenances. Locks, gates, doors, barricades, chains, enclosures, signs, tags or seals which have been installed by or at the request of the *fire code* official shall

not be removed, unlocked, destroyed, tampered with or otherwise vandalized in any manner.

This letter is to inform you that you have thirty (30) days from October 17, 2018, to be in compliance with the Indiana/International Fire Codes noted above. Failure to comply will result in further action including, but not limited to, fines and penalties per the Evansville Municipal Code.

Any new tenants will be limited to B, S2 or f2 occupancies, other occupancies will comply with all current codes including but not limited to required fire area separations and/or fire sprinkler protection. No increased occupancy on upper level without approval of EFD. Upper level will be protected by beam smoke detectors. Remove all heads on all lower level sprinkler systems by 03/01/18. Owner desires to have option of upgrading one or more of the main level 14 riser systems to wet system and will comply with NFPA 13 and 25 for those systems. WHEREAS, a fire watch is a temporary measure intended to ensure continuous and systematic surveillance of a building or portion thereof by one or more qualified individuals for the purposes of identifying and controlling fire hazards, detecting early signs of unwanted fire, raising an alarm of fire and notifying the Fire Department (hereinafter, "Fire Watch");

WHEREAS, Indiana Administrative Code 675 IAC 22-2.5-5 states that whenever it is essential for public safety, the fire chief for the Fire Department (the "Fire Chief") may require Obligor to employ one (1) or more qualified persons to be on duty to serve as a Fire Watch for the Property;

WHEREAS, the Fire Chief has deemed it essential for public safety that Obligor employ a Fire Watch for the Property; and

WHEREAS, Obligor agrees to employ a Fire Watch per the terms and conditions of this Agreement.

NOW, THEREFORE, the Parties agree as follows:

- 1. <u>Fire Watch Contractor</u>. Obligor shall contact and employ a qualified fire watch contractor to commence the Fire Watch on the Property. A qualified fire watch contractor shall be a certified firefighter who has completed the minimum mandatory training under Indiana law. The fire watch contractor must be approved by the Fire Chief, with such approval to be made in the Fire Chief's sole discretion.
- 2. <u>Fire Watch Duties</u>. Obligor agrees that it shall require its fire watch contractor as employed in Section 1 to follow the Fire Watch Protocol that is attached hereto as <u>Exhibit A</u>.
- 3. <u>Fire Department Acting as Fire Watch Contractor</u>. During the period between the Fire Chief determining that a Fire Watch is necessary and Obligor employing a qualified fire watch contractor

to commence the Fire Watch, if the Fire Department must utilize its own firefighters to commence the Fire Watch, then Obligor shall reimburse the Fire Department for any wages, overtime or other fees incurred by the Fire Department in performing such duties. The Fire Department shall invoice such wages, overtime or other fees to Obligor. Obligor shall then make payment to the Fire Department within ten (10) days of receiving such invoice. In the event of non-payment, Obligor agrees to pay all of Fire Department's reasonable attorneys fees, collection costs, court costs and expenses associated with the collection of any amounts owed under this section.

- 4. <u>Termination of Fire Watch</u>. A Fire Watch commenced under this Agreement may only be terminated upon the sole discretion of the Fire Chief or the Fire Chief's designee.
- 5. <u>Governing Law and Venue</u>. This Agreement shall be governed by and construed in accordance with the laws of the state of Indiana. In the event of any litigation between the parties hereto concerning this Agreement or any matters related thereto, such action shall be brought in state court in Vanderburgh County, Indiana.
- 6. <u>Entire Agreement</u>. This Agreement contains the entire agreement between the parties respecting the matters herein set forth and supersedes all prior agreements and understandings between the parties hereto respecting such matters.

- e. Maintain a log of Fire Watch activities.

- g. Personnel performing a Fire Watch cannot have any other duties than the Fire Watch.

Frequency of Fire Watch Patrol

Fire Watch personnel shall patrol the entire facility every 15 minutes in the following situations:

- a. The facility has people sleeping in it.
- b. The facility is in institutional occupancy.
- c. The facility is occupied assembly occupancy.

All other facilities that do not meet these criteria shall have Fire Watch personnel patrol the facility every 30 minutes.

Record Keeping

A Fire Watch log should be maintained at the facility. The log must be available to the Fire Department at all times during the Fire Watch. The log should show the following:

- 1. Address of the facility
- 2. Times that the patrols were completed in the facility
- 3. Name of the person conducting the Fire Watch.
