2	Section III Discontinuance.	2014 IFC, Section 307.1.1 [as amended in 675 IAC 22-2.5- 4(e)]	Section III of Ordinance No. 2020-4 conflicts with Section 307.1.1 of the 2014 Indiana Fire Code – "Discontinuance. The fire chief is authorized to require open burning be immediately discontinued if such open burning constitutes a hazardous condition." Staff's recommendation is to revise ordinance to incorporate the requirements of this section by reference.
3	Section IV, B Discontinuance.	2014 IFC, Section 307.1.1 [as amended in 675 IAC 22-2.5- 4(e)]	See conflict cited in Item #2 above.
4	Section IV, E Extinguishment authority.	675 IAC 22-2.5-4(h)	Section IV, E of Ordinance No. 2020-4 conflicts with 675 IAC 22-2.5-4(h). Section 307.3 (Extinguishment authority) of the 2014 Indiana Fire Code is deleted without substitution in 675 IAC 22-2.5-4(h), and, as such, may not be mandated by local ordinance.

Staff's recommendation is to revise the ordinance to incorporate the requirements of Section 307.5 [as amended in 675 IAC 22-2.5-4(i)] by reference, to avoid any conflicts and duplication.

## **ADDITIONAL COMMENTS**

The Commission's staff advises that the language of Section IV, C of Ordinance No. 2020-4 is unclear as to what the provision is explicitly granting exceptions or special use which may be approved at the discretion of the fire chief (likely compliance with the requirements of the ordinance). The Commission's staff recommends that the City of Greensburg should consider revising Section IV, C for clarity, and should also carefully review the 2014 Indiana Fire Code to ensure that it will not be granting exceptions or special use which is prohibited by the statewide code.
