	What is the basis of your challenge?:	675 IAC 13-2.6 section 907.2.4 stipulates the requirement for fire alarm in an "F" occupancy. The order from Westfield Fire Department indicates that an occupant notification system must be supplied for this facility even though this section of the code is clear that one is not required. Please reference the attached PDF of the architectural drawings that indicates the occupancies and square footages. Our interpretation of this section is that if a fire alarm system is not required, then an occupant notification system is not required - there would be nothing to activate an occupant notification system without a fire alarm. This facility consists of a 77,480 sf single story manufacturing/assembly occupancy (F) as well as an adjoining 2 story 11,025 SF office occupancy (B).

Mr. Stallcop,

Indiana Fire and Building Code requires F Occupancies to have a fire alarm installed per section 907.2.4 of the Indiana Building code. (See code below)

907.2.4 Group F. A manual fire alarm system that activates the occupant notification system in accordance with Section 907.5 shall be installed in Group F occupancies where both of the following conditions exist:

- 1. The Group F occupancy is two or more stories in height; and
- 2. The Group F occupancy has a combined *occupant load* of 500 or more above or below the lowest *level* of exit discharge.

Exception: Manual fire alarm boxes are not required where the building is equipped throughout with an *automatic sprinkler system* installed in accordance with Section 903.3.1.1 and the occupant notification appliances will activate throughout the notification zones upon sprinkler waterflow.

This building does meet **Section 1** as it is two stories in height. Additionally, this code is referring to manual pull stations, not horn strobes. In fact, it does state occupant notification system in this code which would include horn/strobes.

Therefore, under this code, Bastian will need to install horn strobes throughout the building to include the office and manufacture spaces.

You do have the right under Indiana Law to appeal this notice. See attached letter.




Appeal Process:


