

### PETITION FOR ADMINISTRATIVE REVIEW AND STAY OF EFFECTIVENESS

Beech Meadow Apartments, LLC ("Beech Meadow"), by counsel, pursuant to I.C. 4-21.5-3-7, petitions for administrative review of twenty three (23) Fire and Building Code Enforcement Code Inspection Report Orders, Identification Numbers BU29678, 680, 681, 682, 683, 684, 685, 686, 688, 689, 690, 691, 692, 693, 694, 695, 696, 697, 698, 701, 702, 703, and 704 (the "Orders"). Copies of the Orders are attached as Exhibit 1. The Orders were issued to Beech Meadow by the Division of Fire and Building Safety, Indiana Department of Homeland Security. Beech Meadow also petitions for a stay of effectiveness of the Orders. In support of this Petition, Beech Meadow states as follows:

- 1. Beech Meadow owns the Beech Meadow Apartments, the entity to which the Orders were specifically directed.
- 2. The Orders were received on December 14, 2018, as evidenced by the signature and date on each order.
- 3. Beech Meadow is represented by: Bose McKinney & Evans LLP, 111 Monument Circle, Suite 2700, Indianapolis, Indiana 46204. All communications regarding this appeal should be sent to the attention of Daniel P. McInerny at the address above or at <a href="mailto:dmcinerny@boselaw.com">dmcinerny@boselaw.com</a> or (317) 684-5102.
- 4. Beech Meadow is aggrieved and adversely affected by the issuance of the Orders, as set forth in detail below:
- a. Beech Meadow has owned the Beech Meadow Apartments for approximately eleven (11) years.

- b. Subsequent to its purchase, the Beech Meadow Apartments have been inspected on multiple occasions, and no building code violations were found.
- c. The Orders all contain the same alleged violation "Required rear exit was eliminated. Restore and maintain the rear exit." See the Orders.
- d. Beech Meadow has eliminated no rear exits subsequent to its purchase of the Apartments. Therefore, Beech Meadow did not eliminate any rear exits from the Apartment buildings.
- e. The Orders state that the violation must be corrected by January 14, 2019. Even if the Orders are valid, which Beech Meadow does not admit, the required corrective action for twenty three (23) buildings cannot be accomplished by January 14, 2019. Therefore, Beech Meadow is petitioning for a stay of effectiveness of that corrective action deadline.
- 5. Beech Meadow is requesting administrative review of the entirety of each of the Orders.
- 6. Beech Meadow did not engage in the conduct which serves as the basis for each of the Orders. Beech Meadow has engaged in no activity which violates any applicable building code. The issuance of the Order is arbitrary and capricious, an abuse of discretion, or otherwise not in accordance with law. For these reasons, it requests that the Orders be overturned.
- 7. Pursuant to I.C. 4-21.5-3-7(d), Beech Meadow requests the opportunity to conduct informal proceedings to settle the matter to the extent allowed by law.
- 8. Pursuant to I.C. 4-21.5-3-7(a)(3)(A), this Petition for Administrative Review and Stay of Effectiveness is timely filed.

WHEREFORE, Beech Meadow Apartments, LLC, by counsel, respectfully requests that its Petition for Administrative Review and Stay of Effectiveness be granted, that the Orders be overturned, or in the alternative, the parties be allowed to conduct informal proceedings to settle the matter, and that all other just and proper relief be granted.
