Doug,

The Architect gave me the initial hardship numbers. They are trying to get some documentation on the move cost from the museum. However here is the initial response back from the Director of the museum that explains the time and cost impact:

We will do our best. The immediate impact will be that we will have to defer the pickup of our ancient jewelry collection, which is currently being stored in a vault on campus. Anita had scheduled this for March. Such a delay will impact other parts of our move back in schedule, which could be compared to the work of an air traffic controller bringing in a fleet of aircraft for series of tightly coordinated safe landings. The cost of such a ripple effect is difficult to calculate. It is not so much of a money question, but a question of impact to our tight timeframe due to rescheduling. So the potential cost could be anywhere from a few thousand dollars to over \$100,000, especially if we have to hire additional staff to help us.

I realize that you are extremely busy and I would not push the issue if it was not so important.
