Conditions:

An after party will be held on the late afternoon and evening of May 4, 2019, at Mad Paddle Brewery for the 2019 Hanover College Alumni Achievement Award event to be held on campus earlier in the day. The after party will utilize an existing 1st floor space not previously approved for Assembly use of just under 2,500 sq ft of area - see attached for details.

The building is an historic structure built in the 1870's as a feed mill-grain elevator, and is classified as Type IIIB Construction.

- 1. A fire watch per Sec. 403.1, IFC, will be provided for the event.
- 2. Two (2) means of egress at grade will be provided for the room in question. Temporary signage will be provided as necessary to indicate means of egress from the room.
- 3. There will be no inside cooking for the event food will be provided by a food truck.
- 4. The Tap Room and Outside Patio have been previously approved by State CDR and/or local permit for use as proposed.


