C TABLED BY PROPONENT 11/02/2021.

c. The code prohibits corridors from serving as supply, return, exhaust, relief, or ventilation air ducts. The request is to allow corridors to serve as exhaust plenums with corridor door undercuts. The proponent states that outside air will be introduced mechanically into student rooms, a portion of which will be used as the make-up air for restrooms.

## 21-10-34 Project:0 BODNER RESIDENCE, INDIANAPOLIS

TABLED BY COMMISSION 11/02/2021.

The Residential Code requires structure exterior walls with a fire separation distance less than 3 feet to have not less than a one-hour fire resistive rating with exposure from both sides and cannot have any openings. The request is to allow exterior wall and roof overhang to not be firerated within the 5 feet from property line.

- C b. The code requires openings in exterior wall perpendicular and within 4 feet from a fire wall termination to be fire-rated. The request is to allow the openings to not be fire-rated (Park Ave Buildings). The openings will each be protected with sprinklers located within 12 inches horizontally of the openings at the ceiling level.
- C 21306
  - a. The code prohibits buildings or structures from exceeding its allowed building height and area based on the construction type. The request is to allow a new 4-story residential building to exceed the allowable height by one story. The proponent states that exterior walls will be 1-hour rated, not required for type V-B construction.

## Carmel High School Natatorium Additions and Renovations.Carmel

- C b. The code requires a structurally independent wall in order to comply with unlimited area for E use group to be two stories. The request is to utilize the three story existing portion of the school that has a four (4) hour area separation wall, however, it is not structurally independent.
- C f. The code states that the entire building needs to be sprinklered throughout in order to take the exception for rated corridors. The request is to allow for the existing auditorium to not be protected as it is protected by a fire barrier not a fire wall. The addition will be protected.
- C d. The code requires an unlimited area E occupancy to have 60 of open yard space. The request is to have 40 feet on the east side of the building for a total of 400 lineal feet. This is an existing condition.
- C c. The code requires a fire alarm system to activate an emergency voice and alarm communication system, when the occupant load is 1,000 or more. The request is to allow the new natatorium addition to an existing high school which will have an occupant load of over 1000 people and will not have an emergency voice/alarm communications system.
- C e. The code requires a sprinkler system to be provided in the addition to the unlimited area high school with an assembly over 1000 occupants. The request is to allow the sprinkler system to be omitted above the swimming pool water surface. Similar variances have been approved.
- C 21334
  - a. The code requires the entire building to be sprinklered throughout in meet the unlimited area provisions of the code. The request is to allow for the addition of 92,000 square feet, which will be sprinklered. The existing auditorium will continue to not be sprinklered.

a. The code states the use of a temporary structure will not exceed a maximum time of 90 days in the same location. The request is to allow for the use of the temporary stage structure from March 1 to November 30, 2022. The proponent states that stage and truss structure has been evaluated by a structural engineer for compliance with the 2014 Indiana Building Code.

b. The code states the use of a temporary structure will not exceed a maximum time of 90 days in the same location. The request is for shipping containers to remain in place from March1 through November 30, 2022. The proponent states that new openings in container walls have been reinforced with structural steel bracing elements designed in accordance with Chapter 16 and 22, of IBC.

### **Square Cat Vinyl,INDIANAPOLIS**

b. The code states an accessible route shall directly connect the performance area to the assembly seating area where a circulation path directly connects a performance area to an assembly seating area. An accessible route shall be provided from performance areas to ancillary areas or facilities used by performers. The request is to allow a portable ramp be used for access in lieu of a permanently installed ramp. The proponent states that the ramp will comply with the 1:12 slope requirements and be readily available for use as needed.

C 21355

a. The code states that an automatic sprinkler system shall be provided for Group A-2 occupancies when the fire area has an occupant load of 100 or more. The request is to allow the occupant load of 225 for the expanded tenant space without a sprinkler system. The proponent states that (3) exits are provided at a distance of 85 feet.

a. The code requires separation between and H-4 occupancy and an S-1 in fully sprinklered buildings. The request is to not provide a separation between the S-1 and H-3 occupancies. The proponent states that closely spaced sprinklers will be provided along the H-3 tenant side of the existing tenant separation wall.

b. The code prohibits buildings or structures from exceeding the height, number of stories, and allowable area based on the construction type. The request is to allow the building to exceed the allowable area with the addition of the H-3 occupancy. The proponent states that the hand sanitizers to be stored are all water miscible. Sanitizers are in individual containers up to 1 gallon, packaged in cartons. Large spills are not likely to occur.

The fire barriers or horizontal assemblies, or both, separating fire areas of mixed occupancies shall have a fire-resistance rating of not less than the highest value indicated in Table 707.3.10 for the occupancies under consideration. The are requesting an extension to complete the fire barrier installation by June 30,2025.

## **Central Christian Church Temporary Homeless Shelter, Indianapolis**

The code prohibits a building from changing its character or use causing it to be classified within a different occupancy group, unless the building is made to comply with new construction. The request is to allow the 2,500 square feet gymnasium space to be used as a homeless shelter for up to 70 individuals on an annual basis beginning with this year without being made to comply with the Commission's rules for a change of occupancy from A-3 to R-2. The proponent states the gymnasium is on the ground floor and has direct access to two remotely located exterior exits. The shelter will be fully staffed 24/7 during the time of use as a homeless shelter. There have been two previous variances granted for the building.

The request is to have the patient room toilets to be located 28 inches from sidewall. The proponent states that this will allow for the opportunity to have staff help patients to the toilets.

  - a. The code requires a grab bars to be wall mounted and stationary on the side wall. The request is to have fold-up grab bars. The proponent states these will support for the patient and allows staff to fold the bars up and out of the way when they need to physically assist a patient to the toilet.
