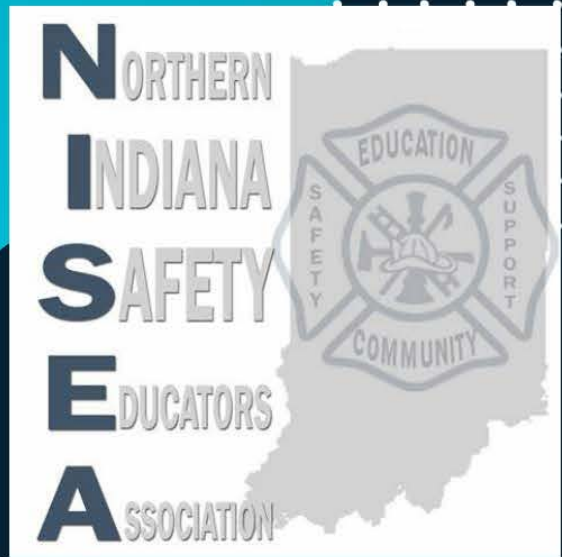

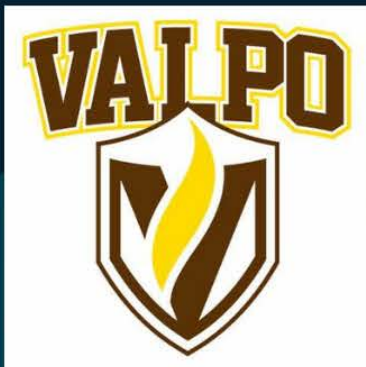

EXECUTIVE SKILL SERIES: EXERCISING LEADERSHIP ETHICALLY

National Fire Academy Course

Course Description:

This two-day course provides students with the ability to recognize ethical dilemmas in the context of their environments, apply a decision model to resolve these dilemmas, render ethical decisions, and defend under scrutiny the resulting decisions that were made in an effort to resolve these dilemmas.

The scope of this course is to provide a developmental education experience for those in positions of authority who regularly must make decisions when the choice of decisions is difficult because of the gray area that separates the issue in question from right or wrong. It also involves challenges that may involve risk, and there may be "casualties". This course is about how to act, behave, or decide where there is no content clarity, legal precedent or procedure, or no opportunity to exercise leadership.

As the combustibles burn, the interior instructors will have the ability to control the conditions in the flashover chamber through combined use of ventilation and "pencil of water." It is through this management of ventilation and water that firefighters are able to experience a realistic observation of a flashover.

The training begins in the classroom with a 90-minute presentation on flashover followed by required vitals check and gear inspection prior to live fire training. All firefighters will need to have NFPA compliant PPE including boots, bunker pants, bunker coat, hood, helmet, structural firefighting gloves, and mask. External helmet visor shall be removed from helmet. Firefighters will also need at least a 45-minute air bottle (can be refilled AFTER live fire training). Firefighters will also be required to have long pants and at least one long sleeve shirt to wear under PPE during fire evolutions. No facial hair beyond a mustache that does NOT interfere with mask seal on jawline.

COURSE DESCRIPTION

CFR focuses on emergency response to a cyber-attack that has crippled or disabled critical cyber-infrastructure. CFR combines instructor led classroom lecture with hands-on computer lab applications to prepare first responders to effectively counter a cyber-attack and restore critical infrastructure as quickly and efficiently as possible. Course participants are trained to use cyberterrorism response tools against real world simulated cyber-attacks and learn the proper steps of incident response to include incident assessment, detection and analysis, and the containing, eradicating, and recovering process from a system or network-based attack.
