Maintain and support server hosting infrastructure system administration on 284 Windows platform servers. Provide technical resolution to maintain 99.9% up time for operational readiness. Assist and coordinate Office moves/adds/changes for 120 local DFR offices and 10 large call centers statewide. The team provides infrastructure system administrative support for FSSA co-partners with application infrastructure requests pertaining to the file servers, network firewall connectivity, network designs and business recommendations. The team acts as IOT liaison for FSSA/DFR with all IOT groups to assist with technical requests, projects, or follow-up questions. We follow IOT policy and procedures when working within the FSSA DFR infrastructure.

Our Customers:

FSSA's Division of Family Resources (DFR). This division houses data for more than 1.4 million eligible recipients of assistance and 1.5 times that number of applications per year. DFR is an \$8 billion agency that provides benefit assistance under such programs as Medicaid/SNAP/TANF, HIP 2 and the Affordable Care Act. The Agency division has co-partners (Deloitte/IEDSS, Moser, ICES, Conduent, and Maximus) that support applications, training initiatives and tier 1 help desk calls.

The FSSA DFR budget is billed for 5 IOT dedicated employees assigned to FSSA/DFR.

Our Metrics:

Server and Storage Availability 99.9%+ G; 96.9%+ Y; <96.9% R Mon-Fri 6am-6pm excluding state holidays.

Major Accomplishments:

- Automate and maintain a Rapid 7 report that identifies security vulnerabilities and remediation for DFR servers to lower the Risk score to 25K or below.
- Maintain and automate an Agency billing report showing total monthly costs for server hosting and associated Billing codes.
- Assist Vendors to SOI system policy and procedures including workflows, roles and responsibilities, service accounts, access and all their business requirements to access SOI applications for DFR.

Current Projects:

- Migrate DFR Window 2012 servers.
- Assist with Security documents MARS-E to assist with necessary audit requirements.
- Document, coordinate DFR office moves/add/changes for office relocations statewide.
- Assist with DFR Ricoh multi-functional printer refresh and vendor transition.
- Assist vendors with their strategic projects to meet initiatives and timelines.
