

INTIME Guide to Making a Tax Return Payment

For Individual Income Tax Customers

The Indiana Department of Revenue (DOR) provides an easy and efficient way for **individual income tax** customers to securely pay their state taxes electronically. Return payments can be made via INTIME, DOR's e-services portal at <u>intime.in.gov</u>, **with or without** logging in to an account.

Non-Logged-in Tax Return Payment via INTIME

Step 1: Go to INTIME, locate the "Payments" panel, then click on "Make a payment."



Step 2: Locate the "Non-bill payments" panel and click on the preferred payment method. Payments can be made with a bank account (no fee) or credit/debit card (fee).

Step 1: Log in to INTIME.

Step 2: Go to the "Summary" (tab) page to see "Account" information panel. **Step 3:** Click on "Make a payment" to begin the payment process.
