Sec. 6. (a) Before October 1, 2019, the office of the secretary shall prepare a report containing the number of Medicaid fee-for-service nonemergency medical transportation claims paid by:

- (1) vehicle type;
- (2) Medicaid recipient category; and
- (3) whether the recipient for which the claim was paid resided in:
  - (A) the community;
  - (B) a health facility;
  - (C) an intermediate care facility for individuals with intellectual disabilities;
  - (D) a hospital; or
  - (E) another location.

(b) beginning June 1, 2016, through May 31, 2019, the claims data reported in subsection (a) must be organized by month.

(c) The office of the secretary shall submit the report prepared under subsection (a) to the commission.

Overview

Medicaid is an assistance program enacted to provide health care services to individuals who are low-income, aged, blind or disabled, and to families with children. Started in 1965, it is funded with federal and state monies and administered by each state. Currently, Indiana Medicaid covers over 1.4 million Hoosiers. Non-Emergency Medical Transportation (NEMT) is a covered service for members enrolled in Medicaid. NEMT is a statewide service to provide transports for eligible members to and from non-emergency medical services covered by Indiana Medicaid. This non-emergency transportation should only be requested if the member has no other transportation option available. Members with reliable transportation, access to public transportation or family, friends or other options to get to their appointments are expected to exhaust these options first.

Beginning June 1, 2018, the NEMT benefit for Traditional Medicaid members was provided through a transportation broker. The broker's responsibilities includes ensuring that members are transported by licensed and credentialed transportation providers. Additional responsibilities consist of provider management, eligibility verification, trip reporting, claims payment and grievance management. This model also helps ensure quality controls are in place and safety and program integrity standards required by the US Centers for Medicare and Medicaid Services (CMS) are met, including the use of the most efficient, appropriate transportation to meet the member's needs. States also work with transportation brokers to help reduce or eliminate fraud, waste and abuse by transportation providers by relying on the broker to validate that trips only happen for medical purposes, monitor appropriate mileage to reduce excessively long trips, and

credential transportation providers to achieve a more consistent and safer standard of care for members.

The focus within a broker model is on providing consistent, safe, appropriate and reliable transportation. This requires continuous efforts to grow a safe, efficient and reliable network of transportation providers to meet the increased needs and demands of our traditional Medicaid members. Member utilization is managed through the promotion of the gas reimbursement and public transportation options and the determination of the most appropriate mode of transportation to meet the individual's needs.

Non-emergency medical transportation has been a brokered benefit within Indiana Medicaid managed care programs since the 1990s.

### Report content

This report covers Indiana Medicaid members in the Fee-for-Service program, also referred to as Traditional Medicaid. The data in this report is based on NEMT transportation procedure codes and claims submitted to Indiana Medicaid and their contractors for payment for services. Claim counts are based on the date the claim is paid and not on the date of service. Data from June 2016 through May 2018 includes all Traditional Medicaid members and all claims paid by the Medicaid fiscal agent. Data from June 2018 through May 2019 includes all Traditional Medicaid members, including those eligible for brokered NEMT services, and paid both by the fiscal agent and the broker. Claim counts do not include members accessing transportation through the gas reimbursement or public transportation means.

Data on vehicle type is reported in three (3) categories: ambulance, ambulatory and wheelchair based upon NEMT transportation procedure codes. Ambulance includes those transports requiring a stretcher and those requiring Advance Life Support (ALS) or Basic Life Support (BLS) services. Ambulatory includes trips by taxi, other common carriers, public transportation and gas reimbursement. Wheelchair rides are provided by EMS and common carriers with a subspecialty of non-ambulatory indicating wheelchair vans.

The Medicaid program has categorical eligibility requirements which must be met in order for individuals to receive assistance. The method used to determine income eligibility, the type of coverage, and the scope of the benefits provided varies based on the category under which individuals are eligible. There are a total of 35 eligibility categories. Monthly data for the Recipient Aid Category contains a subset of the 35 categories based on the individual's category on the last day of the reporting month and eligibility for NEMT; it excludes rides provided through managed care. Due to HIP eligibility assignments, rides may be reported here for rides provided during the presumptive eligibility period and before the member was assigned to a managed care health plan.

Data is consolidated based on four places of residence based on provider enrollment and claims experience data. Individuals residing in Intermediate Care Facilities for Individuals with Intellectual Disabilities (ICF/IID) are reflected in the ICF/IID category. Individuals residing in a facility enrolled as an extended care facility, such as a nursing facility or residential care facility, are in the Health Facility category. Individuals whose trips were for hospital discharges are reported in the Hospital category. Individuals residing in their own homes or in community

group homes and all others not included in the first three groups are reflected in the Community category.

The member's residential assumption is based on data from the Medicaid eligibility system merged with the CoreMMIS system which identifies level of care, services rendered and claims submitted. To identify hospital as a place of residence, analytics were used to match a transportation claim with an origination of a hospital address to a hospital claim on the same date of service. To identify a health facility, facilities with provider type 3 and specialty codes 030, 032, 033, and 034 as well as provider type 32 sociality code 350/subspecialty A04 were isolated and match to transportation claims on the date of the transportation service. ICF/IID residents were identified as provider type 3 specialty code 031. For ICF/IIDs, the volume is negligible due to transportation being included in the facility per diem rate.

For the experience period of less than 12 months there are limitations to the data. Claims data for June 2018 through May 2019 is assumed to be incomplete. The timely filing limit for transportation providers to submit claims is 365 days for claims up to and including December 31, 2018. Beginning January 1, 2019, the timely filing limit was reduced to 180 days to submit a claim for payment ([BT 201829](#).) Therefore, at the time the data analytics was completed for this report the claims data is assumed to be incomplete.

In addition to timely filing and system processing timelines, claims adjustments may extend the period in which complete data is obtained to 16 months.
