Note 1: This payment calculation includes Medicaid days for providers that are associated with hospitals included in the DSH eligibility determination.

Note 2: MIUR values reported above have been rounded, however the initial allocations and additional allocations above are based on the original, unrounded MIURs. As such, these allocations may differ slightly from any calculations using the amounts shown above.

Note 3: An initial allocation of the \$2M pool is made, based on the hospitals' MIURs. However, in the event that allocation exceeds a hospital's HSL, that hospital's payment is limited to the HSL. The remaining allocation not able to be paid to the hospital due to the HSL limiter, is then allocated to the other hospitals based on their MIURs. In this case, Michiana Behavioral Health Care's DSH is limited to its 2010 HSL.

Note 4: Wabash Valley Hospital had a change of ownership effective January 15, 2010. The SFY 2010 payment reflected in this report was divided proportionately between Wabash Valley Hospital and River Bend Hospital (#200980250) based on the effective CHOW date.
