#### Call to Order

### **Consumer Services and Health Care Regulation Commission**

Emergency Adoption of Amendment of Emergency Rule to Clarify IC 16-44-2

Shane Hatchett, Chief of Staff and Kelly MacKinnon, Director of Legal Affairs presented the amendment to clarify IC 16-44-2 for emergency adoption. The Indiana Department of Health regulates the sale of gasoline in Indiana. One of the ways gasoline is regulated is through the testing of gasoline volatility by using Reid Vapor Pressures (RVP) readings as set forth in IC 16-44-2-8. Indiana sets RVP pounds per square inch (PSI) limits based on the month of the year, with different PSI levels in summer months. RVP PSI are also regulated at the federal level. Indiana Code references federal tax code to define gasohol, but that definition is different than what is used by the EPA, which generally refers to E10 and E15 blends. In 2019, the federal government authorized the sale of E15 during summer months based on PSI limit changes, but it is not clear whether Indiana allows this sale because Indiana has not updated the gasohol definition since that federal action. This emergency rulemaking establishes a definition of gasohol to clarify that E15 can be sold in Indiana in summer months. This is an emergency adoption because June is one of the months at issue for sale of E15.

Ms. Goff asked for comments from the Board, staff and/or public for discussion purposes. On a motion made by Dr. Stephen Tharp, seconded by Dr. Naveed Chowhan and passed by majority roll call vote of virtual attendees, the Board approved clarification to IC 16-44-2 for emergency adoption.
