INDIANA GAMING COMMISSION BUSINESS MEETING

November 23, 2020 Virtual via Microsoft Teams Live Stream Indianapolis, Indiana

Call to Order and Roll Call:

Chairman Michael B. McMains called the meeting to order at 2:24 p.m. local time. A quorum was present.

Upon motion by Jason Dudich, second by Susan Williams, and unanimous vote of those present, the Commission approved the proposed minutes from the July 10, 2020 Business Meeting.

Report of the Executive Director:

Executive Director Tait began her report by providing a staffing update. Ms. Tait introduced a new commissioner, Chuck Cohen. He is a certified fraud examiner, certified economic crime forensic examiner and retired Indiana State Police Captain. Ms. Tait acknowledged that we are thrilled to have him join the team. Ms. Tait acknowledged former commissioner Mike Herndon for his service and dedication to the Gaming Commission. Secretary Svetanoff and Commissioner Saxon recently resigned from the Commission and their replacements have not yet been identified. Indiana Gaming Commission hired one new person since the last meeting: Ashley Black, Assistant Controller and there were three promotions: Greg Lee from Gaming Agent Assistant Supervisor to Gaming Agent Supervisor, Marecia Dewar from Gaming Agent to Gaming Agent Assistant Supervisor, and Brock Pilgrim from Gaming Agent Supervisor to Central Zone Assistant Director. Since the July 10, 2020 Business Meeting, the Commission has added 21 individuals to the Exclusion List, granted 5 waivers, and conducted three-year reinvestigations for Patriot Gaming, Genesis Gaming, DraftKings Paid Fantasy Sports and FanDuel Paid Fantasy Sports. Ms. Tait introduced two new General Managers, Kathryn Jenkins, Horseshoe Hammond Casino and Ryan Coppola, Ameristar Casino.

Upon a nomination by Marc Fine, seconded by Susan Williams, and unanimous vote of those present, the Commission approved Jason Dudich to be Secretary of the Commission.

Staff Update Regarding Spectacle Investigation

The IGC's investigation is nearly complete. The regulatory investigation involves matters in addition to the criminal matters previously disclosed by the United States Department of Justice, specifically pertaining to John Keeler and an unnamed former executive of Centaur Gaming. The IGC's investigation has been primarily conducted by four core individuals from both the investigations and audit divisions, and supported by other individuals.

The IGC has conducted 29 separate interviews of both licensees and former licensees. Three individuals declined requested interviews by the IGC, this includes individuals that have previously been or currently are licensed by the IGC. The scope of the review covers financial transactions, ownership transfers, contracts, failures to disclose, improper utilization of funds, improper accounting practices, failure to act within the occupational licensure parameters, ex parte communications and other actions and situations falling outside of the good moral character and integrity standards detailed throughout Indiana statutes and regulations.

Commissioners stated that an update on the status of the investigation shall be presented within 30 days and at that time it will determine if any affirmable actions needs to be taken.
