

**RESOLUTION 1995- 13**

**A RESOLUTION ADOPTING AMENDMENTS TO ARTICLE 1, RULE 1;  
ARTICLE 2 RULES 1, 2, 3 AND 5; AND ADOPTING ARTICLE  
1 RULE 4, ARTICLE 4, RULE 1, ARTICLE 5 RULES  
1 AND 2; AND ARTICLE 13, RULE 1**

**WHEREAS**, the Indiana Gaming Commission (the "Commission") has the power and duty under IC 4-33-4-1 to fully and effectively execute IC 4-33 (the "Riverboat Gambling Law");

**WHEREAS**, the Commission has the power and duty to take any reasonable or appropriate action to enforce the Riverboat Gambling Law;

**WHEREAS**, under IC 4-33-4-2, the Commission is to adopt rules to administer the Riverboat Gambling Law; establish conditions under which riverboat gambling may be conducted; provide for the prevention of practices detrimental to the public interest; provide for the best interests of riverboat gambling; inspect riverboats and the permits or licenses necessary to operate riverboats; and impose penalties for noncriminal violations of the Riverboat Gambling Law;

**WHEREAS**, under IC 4-33-4-3, the Commission is to adopt rules it determines necessary to protect or enhance the credibility and integrity of gambling operations authorized by the Riverboat Gambling Law, and the regulatory process provided in the Riverboat Gambling Law.

**WHEREAS**, the Commission has begun promulgation of these rules pursuant to IC 4-21.5, and these rules are to be published in the Indiana Register on July 1, 1995 and public comment is scheduled to occur on July 27, 1995;

**WHEREAS**, the promulgation process for the final promulgation of these rules will take approximately three (3) to six (6) months;

**WHEREAS**, the Commission has been duly advised in the matter and finds that the Commission should act promptly to adopt these proposed rules and apply them on an interim basis until the promulgation process is complete.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

**SECTION 1. SCOPE.**

These guidelines apply to each applicant, each licensee, any person who does business with an applicant or licensee, and any person who is a patron of a Riverboat Gambling Operation.

**SECTION 2. DEFINITIONS.**

The definitions set forth in IC 4-33-2 and 68 IAC 1-1 apply to this resolution.

**SECTION 3. ADOPTION OF THE PROPOSED RULES.**

The Commission adopts the following proposed rules pending the promulgation process:

The Commission will accept written public comment submitted on or before July 27, 1995, and will hold a hearing to accept oral public comment on July 27, 1995, at 1:00 p.m. in the Auditorium of the Government Center-South, 402 West Washington Street, Indianapolis, Indiana.

**SECTION 4. EFFECTIVE DATE.**

This RESOLUTION is effective immediately.

**SECTION 5. EXPIRATION DATE.**

This RESOLUTION expires thirty (30) days from the date and time that the Secretary of State accepts the rules listed in Section 3 for filing.


