

## **RESOLUTION 1995- 21**

**A RESOLUTION ADOPTING, AS FINAL RULES,  
68 IAC 1-1-2.1; ARTICLE 1, RULE 4; 68 IAC 2-1-4;  
68 IAC 2-2-3; 68 IAC 2-2-4; 68 IAC 2-2-5; 68 IAC 2-3-4;  
68 IAC 2-5-1; 68 IAC 2-5-2; 68 IAC 2-5-5; ARTICLE 4,  
RULE 1; ARTICLE 5, RULES 1 AND 2; AND ARTICLE 13, RULE 1**

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The following factors have been considered by the Commission:

1. The Commission has begun promulgation of these rules pursuant to IC 4-21.5, and these rules were published in Volume 18 of the *Indiana Register*, pages 2418 through 2446, on July 1, 1995.
2. The Commission held a public hearing on these rules on July 27, 1995, and accepted written comment on the same. The verbal comments from the public hearing were transcribed, and the transcript as well as the written comments have been provided to the Commission members for review.
3. The promulgation process for the final promulgation of these rules will take approximately four (4) to six (6) months.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING  
COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

### **SECTION 1. SCOPE.**

This resolution applies to each applicant, each licensee, each riverboat license applicant, any person who does business with an applicant or licensee, and any person who is a patron of a Riverboat Gambling Operation.

### **SECTION 2. DEFINITIONS.**

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

### **SECTION 3. ADOPTION OF THE FINAL RULES.**

changes which the Commission or the Legislative Services Agency may make before the rules are printed as final rules in the *Indiana Register*.

**SECTION 5. EXPIRATION DATE.**


This RESOLUTION expires thirty (30) days from the date and time that the Secretary of State accepts the rules listed in Section 3 for filing.
