

RESOLUTION 1996- 60

**A RESOLUTION ADOPTING, AS FINAL RULES,
68 IAC 1-2-5.1; 68 IAC 2-2-6.1; 68 IAC 3-4; 68 IAC 2-3-6.1;
68 IAC 2-6-37; 68 IAC 10-6; 68 IAC 10-7; and AMENDING
68 IAC 14-3-2; 68 IAC 14-3-3; 68 IAC 15-9-1; and 68 IAC 15-9-4**

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The following factors have been considered by the Commission:

1. The Commission has begun promulgation of these rules pursuant to IC 4-21.5, and these rules were published in Volume 20 of the *Indiana Register*, pages 45 through 55, on October 1, 1996.
2. The Commission held a public hearing on these rules on October 24, 1996, and accepted written comment on the same. The verbal comments from the public hearing were transcribed, and the transcript as well as the written comments have been provided to the Commission members for review.
3. The promulgation process for the final promulgation of these rules will take approximately four (4) to six (6) months.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING
COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

SECTION 1. SCOPE.

This resolution applies to each applicant, each licensee, each riverboat license applicant, any person who does business with an applicant or licensee, and any person who is a patron of a Riverboat Gambling Operation.

SECTION 2. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3. ADOPTION OF THE FINAL RULES.

The Commission adopts the following final rules pending completion of the promulgation process:

Article 1 General Provisions

68 IAC 1-2-5.1 Requests to address the Commission.

Article 2 Licenses; Approval of Associated Equipment

68 IAC 2-2-6.1 Requirement that certain employees of a supplier licensee obtain an occupational license.

68 IAC 2-3-6.1 Post-licensing policies and procedures.

68 IAC 2-6-37 Operation of progressive controller-normal mode.

Article 3 Minority and Women's Business Enterprises

68 IAC 3-4 Challenges of the Designation of a Certified Minority or Women's Business Enterprise.

Article 10 Conduct of Gaming

68 IAC 10-6 Caribbean Stud Poker

68 IAC 10-7 Let It Ride

The Commission adopts the following amendments to rules that have been fully promulgated by the Commission:

Article 14 Gaming Equipment

68 IAC 14-3-2 Playing card specifications.

68 IAC 14-3-3 Dice specifications.

Article 15 Accounting Records and Procedures

68 IAC 15-9-1 Applicability; general provisions.

68 IAC 15-9-4 Chips and tokens redeemed by nongaming occupational licensees.

Section 12 of the document containing the rules listed above, LSA Document #96-32(F), consolidates LSA Document #96-66, LSA Document #96-112, LSA Document #96-113, LSA Document #96-114, LSA Document #96-117, LSA Document #96-142, and LSA Document #96-143 with this document. Section 12 is a noncode provision that serves only to effectuate the consolidation.

Pursuant to IC 4-22-2-27 through IC 4-22-2-30, the Commission adopts the rules which are being forwarded to the Attorney General's Office on or before December 27, 1996 for

approval as final rules pursuant to IC 4-22-2-32. Upon approval by the Attorney General's Office, the rules will be submitted to the Governor's office for approval pursuant to IC 4-22-2-33. After the rules have been approved or deemed approved by the Governor, the rules shall be submitted to the Secretary of State for filing in accordance with IC 4-22-2-35. The Commission further adopts any stylistic, grammatical, typographical, or other nonsubstantive changes which the Commission or the Legislative Services Agency may make before the rules are printed as final rules in the *Indiana Register*.

SECTION 4. EFFECTIVE DATE.

This RESOLUTION is effective immediately.

SECTION 5. EXPIRATION DATE.

This RESOLUTION expires thirty (30) days from the date and time that the Secretary of State accepts the rules listed in Section 3 for filing.


