

**RESOLUTION 1997-31**

**A RESOLUTION GRANTING PERMANENT OCCUPATIONAL  
LICENSES TO EMPLOYEES AT THE  
CASINO AZTAR IN EVANSVILLE**

The Indiana Gaming Commission("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The following factors have been considered by the Commission:

1. In accordance with IC 4-33-8 and 68 IAC 2-3, suitable applicants for an occupational license are issued a temporary occupational license pending the completion of a background investigation.
2. Temporary occupational licenses were issued to applicants for employment with Aztar Indiana Gaming Corporation ("Aztar") beginning November 20, 1995.
3. The Commission has completed background checks on some of the applicants for occupational licenses at Casino Aztar and is ready to issue permanent occupational licenses to the individuals set forth on the attached list.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING  
COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

**SECTION 1. SCOPE.**

This resolution applies to all individuals set forth on the attached list who applied for a Permanent Occupational License to work for Casino Aztar.

**SECTION 2. DEFINITIONS.**

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

**SECTION 3. GRANT OF PERMANENT OCCUPATIONAL LICENSE FOR  
QUALIFIED INDIVIDUALS.**

The Commission hereby grants permanent occupational licenses to the individuals set forth on the attached list to work for Casino Aztar. The permanent occupational licenses will be valid for a period of one (1) year, from the date the badges are issued by the Commission.

**SECTION 4. CONDITIONS PLACE ON OCCUPATIONAL LICENSES.**


- A. Issuance of the permanent occupational licenses is conditioned upon payment of the appropriate licensure fee by Casino Aztar by September 16, 1997. Failure to remit payment may result in the revocation of any of the occupational licenses.
- B. Casino Aztar or the occupational licensee must request renewal of the occupational license at least thirty (30) days before the expiration of the occupational license in accordance with 68 IAC 2-3-8.

**SECTION 5. EFFECTIVE DATE.**

This RESOLUTION is effective immediately.


