

RESOLUTION 1999-2

A RESOLUTION GRANTING PERMANENT SUPPLIER'S LICENSE TO ATLANTIC CITY COIN & SLOT SERVICE COMPANY, INC. ("AC COIN"), GAMECASH, INC. AND SOUTHWEST SYSTEMS LIMITED

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The following factors have been considered by the Commission:

1. In accordance with IC 4-33-8 and 68 IAC 2-2, suitable applicants for a Supplier's License are issued a Temporary Supplier's License pending the completion of a background investigation.
2. Temporary Supplier's Licenses were issued to applicants to supply goods and services to gambling operations licensed by the Indiana Gaming Commission.
3. The Commission has completed background checks on the Temporary Supplier licensees listed below and is ready to issue Permanent Supplier's Licenses to the following:

GAMECASH, INC.
SOUTHWEST SYSTEMS LIMITED

NOW, THEREFORE, BE IT RESOLVED BY THE INDANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1. SCOPE.

This resolution applies to the Temporary Supplier Licensee listed above in Paragraph Three.

SECTION 2. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3. GRANT OF PERMANENT SUPPLIER'S LICENSE FOR QUALIFIED APPLICANTS.

The Commission hereby grants Permanent Supplier's License to the temporary supplier licensee listed below. The Permanent Supplier's Licenses will be valid for a period of one (1) year, from February 26, 1999 through February 25, 2000.

SECTION 4. CONDITIONS PLACED ON SUPPLIER'S LICENSE.

- A. Issuance of the Permanent Supplier's License is conditioned upon payment of the appropriate licensure fee and the cost of the license investigation by the temporary supplier by March 25, 1999. Failure to remit payment may result in the revocation of their license.
- B. The Suppliers Licensee must request renewal of the Supplier' License at least thirty (30) days before the expiration of the Permanent Supplier's License in accordance with 68 IAC 2-2-8.

SECTION 5. EFFECTIVE DATE.

This RESOLUTION is effective immediately.
