#### **RESOLUTION 2000-44**

#### A RESOLUTION CONCERNING THE RENEWAL OF SUPPLIERS' LICENSES

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The following factors have been considered by the Commission:

- 1. On December 15, 1997, by RESOLUTION 1997-46, a Supplier's License was issued to International Electronic Protection, ("IEP").
- 2. On January 20, 1998, by RESOLUTION 1998-2, a Supplier's License was issued to International Game Technology, ("IGT").
- 3. On February 26, 1999, by RESOLUTION 1999-3 and January 27, 2000, by RESOLUTION 2000-4, IEP and IGT were granted the Renewal of their Supplier's License.
- 4. In accordance with IC 4-33-7-8 and 68 IAC 2-2-8, a Supplier's License must be renewed annually.
- 5. The above named supplier licensees have requested a renewal of the Supplier's License and the renewal will be conditioned upon payment of the renewal fee in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8. If payment of the renewal fee is not received as directed by the Commission staff, the license will be subject to revocation.
- 6. The Commission has determined that the above named supplier licensees remain in compliance with IC 4-33.

# NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

## **SECTION 1. SCOPE.**

This resolution applies to the supplier licensees listed above in paragraphs one and two.

## **SECTION 2. DEFINITIONS.**

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

#### SECTION 3. GRANT OF RENEWAL OF SUPPLIERS' LICENSES.

The Commission hereby grants the renewal of the Supplier's Licenses issued to the suppliers listed below on condition that renewal fee is paid as directed by the Commission staff. The renewed supplier's licenses will be valid for a period of one (1) year from the date of issuance.

## SECTION 4. CONDITIONS PLACED ON SUPPLIER'S LICENSE.

A. The supplier licensees must request renewal of the supplier's license at least thirty (30) days before the expiration of the license in accordance with 68 IAC 2-2-8.
