

RESOLUTION 2002-4

A RESOLUTION CONCERNING THE RENEWAL OF SUPPLIERS' LICENSES

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The Commission has considered the following factors:

1. On March 2, 2001, by RESOLUTION 2001-6, the renewal of suppliers' licenses was issued to Anchor Coin, Inc., GameCash, Inc., A.C. Coin, Dallmann Systems, Inc.
2. On August 23, 2001, by RESOLUTION 2001-28, the renewal of a supplier's license was issued to Bally Gaming, Inc.
3. In accordance with IC 4-33-7-8 and 68 IAC 2-2-8, a supplier's license must be renewed annually.
4. The above-named supplier licensees have requested a renewal of licensure and the renewal fee has been paid in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8. The supplier licensees may have outstanding background investigation fees and will be responsible for payment of the background fees. If payment for the background fees is not received as directed by the Commission staff, the license will be subject to non-renewal or revocation.
5. The Commission has determined that the above-named supplier licensees remain in compliance with IC 4-33.

NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1. SCOPE.

This resolution applies to all supplier licensees listed above in paragraph one and two.

SECTION 2. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3. GRANT OF RENEWAL OF SUPPLIERS' LICENSES.

The Commission hereby grants the renewal of the suppliers' licenses issued to the suppliers listed below on condition that any outstanding background fees are paid as directed by the Commission staff. The renewed suppliers' licenses will be valid for a period of one (1) year from the date of issuance.

ANCHOR COIN, INC.
GAMECASH, INC.
A. C. COIN
DALLMANN SYSTEMS, INC.
BALLY GAMING, INC.

SECTION 4. CONDITIONS PLACED ON EACH SUPPLIER'S LICENSE.

- A. The supplier licensees must request renewal of the supplier's license at least thirty (30) days before the expiration of the license and pay the renewal fee in accordance with 68 IAC 2-2-3 (c) and 68 IAC 2-2-8.

SECTION 5. EFFECTIVE DATE.

This RESOLUTION is effective immediately.
