

## RESOLUTION 2003-56

### A RESOLUTION CONCERNING THE RENEWAL OF SUPPLIER'S LICENSE

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The Commission has considered the following factors:

1. On October 22, 1997, by RESOLUTION 1997-35, the Commission issued a Temporary Supplier's License to Chipco International ("Chipco").
2. On October 23, 2000, by RESOLUTION 2000-40, a Permanent Supplier's License was issued. The Supplier's License was valid for a period of one (1) year, from October 23, 2000 through October 22, 2001.
3. In accordance with IC 4-33-7-8 and 68 IAC 2-2-8, a Supplier's License must be renewed annually along with the payment of a Five Thousand Dollar (\$5,000) renewal fee.
4. On November 2, 2001 and September 30, 2002, the Commission received the annual renewal forms requesting the renewal of Chipco's Supplier's License, for the periods of October 23, 2001 through October 22, 2002 and October 23, 2002 through October 22, 2003, respectively. Both renewal requests were submitted without the \$5,000 renewal fee. In addition to the outstanding \$10,000 renewal fees, Chipco also had an outstanding balance due for background investigation fees.
5. On October 21, 2003, the Commission received the annual renewal form requesting the renewal of Chipco's Supplier's License for the period of October 23, 2003 through October 22, 2004. The Commission also received the \$5,000 annual fee, as well as the outstanding renewal and background investigation fees.
6. The above-named Supplier Licensee has requested renewal of licensure and the renewal fee has been paid in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8. If it is determined that the Supplier Licensee has additional outstanding background investigation fees, the Licensee will be responsible for payment of those fees. If payment for such background fees should not be received as directed by the Commission staff, the license would be subject to non-renewal or revocation.
7. The Commission has determined that the above-named Supplier Licensee remain in compliance with IC 4-33.

**NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:**

**SECTION 1. SCOPE.**

This resolution applies to Chipco International.

**SECTION 2. DEFINITIONS.**

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

**SECTION 3. GRANT OF RENEWAL OF SUPPLIER'S LICENSE.**

The Commission hereby grants the renewal of the Supplier's License issued to the supplier listed below on the condition that any outstanding background investigation fees are paid as directed by the Commission staff. The Suppliers' License will be valid for a period of one (1) year from the date of issuance.

**SECTION 4. CONDITIONS PLACED ON THE SUPPLIER'S LICENSE.**


The Supplier Licensee must request renewal of the Supplier's License at least thirty (30) days before the expiration of the license and pay the Five Thousand Dollar (\$5,000) renewal fee in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8.

**SECTION 5. EFFECTIVE DATE.**

This RESOLUTION is effective immediately.
