

RESOLUTION 2005-32

A RESOLUTION CONCERNING RENEWAL OF SUPPLIER'S LICENSES

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The Commission has considered the following factors:

1. On August 5, 2004, pursuant to Resolution 2004-42, the Commission renewed the Supplier's Licenses held by Gemaco Inc., Atronic Americas, LLC, Osborne Coinage Co., and GPI USA, Inc.
2. In accordance with IC 4-33-7-8 and 68 IAC 2-2-8, a Supplier's License must be renewed annually along with payment of a Five Thousand Dollar (\$5,000) renewal fee.
3. The above-named licensees have requested renewal of licensure and the renewal fees have been paid in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8. The licensees may have outstanding background investigation fees and will be responsible for payment of the background fees. If payment for the background fees is not received as directed by the Commission staff, the license will be subject to non-renewal or revocation.
4. The Commission has determined that the above-named Supplier Licensees remain in compliance with IC 4-33.

NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1: SCOPE

This resolution applies to the Supplier Licensees listed above in paragraph one.

SECTION 2: DEFINITIONS

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3: CONDITIONS PLACED ON EACH SUPPLIER'S LICENSE

The Supplier Licensees must request renewal of the Supplier's License at least thirty (30) days before the expiration of the license and pay the Five Thousand Dollar (\$5,000) renewal fee in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8.

SECTION 4: ACTION TAKEN ON REQUEST FOR RENEWAL OF SUPPLIER'S LICENSES

The Commission hereby:

GRANTS

(GRANTS OR DENIES)

the renewal of the Supplier's Licenses issued to the suppliers listed below on the condition that any outstanding background fees are paid as directed by the Commission staff. The Supplier's Licenses will be valid for a period of one (1) year from the date of issuance.

This resolution is effective immediately.


