**ORDER OF THE INDIANA GAMING COMMISSION
CONCERNING THE RENEWAL OF SUPPLIER'S LICENSES**

In accordance with and subject to Indiana Code 4-33, Indiana Code 4-35, and 68 IAC 2-2 of the Indiana Administrative Code, the Indiana Gaming Commission ("Commission") has previously issued permanent supplier's licenses to: (1) International Game Technology; (2) Midwest Gaming Supply Co.; (3) Atlantic City Coin & Slot Service Co., Inc.; (4) Data Financial, Inc.; (5) Incredible Technologies, Inc.; (6) Digideal Corp.; (7) Lightning Slots, LLC; (8) Technical Security Integration, Inc.; (9) WMS Gaming, Inc.; (10) DEQ Systems Corp.; (11) Elektroncek DD; (12) TCS John Huxley Europe Ltd.; (13) Bally Gaming, Inc. and (14) Patriot Gaming & Electronics, Inc.

A supplier's license is valid for a period of one (1) year and in accordance with IC 4-33-7-8, a supplier's license must be renewed annually along with the payment of Seven Thousand Five Hundred Dollars (\$7,500) as an annual renewal fee. Each of these licensees has requested renewal of licensure and paid the renewal fees. The Commission has determined that the above-named supplier licensees remain in substantial compliance with IC 4-33 and are suitable to hold a supplier's license.


The Commission hereby **GRANTS** renewal of the licenses of each of the suppliers for a period of one year as specified below:

- 4) Data Financial, Inc.: valid March 4, 2012 through March 3, 2013
- 5) Incredible Technologies, Inc.: March 4, 2012 through March 3, 2013
- 6) Digideal Corp.: valid March 17, 2012 through March 16, 2013
- 7) Lightning Slots, LLC: valid March 17, 2012 through March 16, 2013
- 8) Technical Security Integration, Inc.: valid March 17, 2012 through March 16, 2013
- 9) WMS Gaming, Inc.: valid March 17, 2012 through March 16, 2013
- 10) DEQ Systems Corp.: valid March 19, 2012 through March 18, 2013
- 11) Elektroncek DD: valid March 19, 2012 through March 18, 2013
- 12) TCS John Huxley Europe Ltd.: valid March 19, 2012 through March 18, 2013
- 13) Bally Gaming, Inc.: valid March 30, 2012 through March 29, 2013
- 14) Patriot Gaming & Electronics, Inc.: valid March 31, 2012 through March 30, 2013


Each licensee must notify the Commission of its desire to be considered for a subsequent license renewal at least thirty (30) days before the expiration of the license.
