## ORDER 2014-237 PROSPECTIVELY RENEWING THE CASINO OWNER'S LICENSE OF INDIANA GAMING COMPANY, LLC d/b/a HOLLYWOOD CASINO LAWRENCEBURG

The Indiana Gaming Commission ("Commission") adopts the following order pursuant to authority granted it under IC 4-33. In accordance with and subject to Indiana Code 4-33 and Title 68 of the Indiana Administrative Code, the Commission issued a Casino Owner's License to Indiana Gaming Company, L.L.C. d/b/a Hollywood Casino Lawrenceburg ("Hollywood"), effective March 2, 2001. Pursuant to Indiana Code section 4-33-6-12, the license has been renewed annually since inception. The most recent renewal, granted on March 20, 2014, renewed the Casino Owner's License through December 9, 2014.

On October 14, 2014, Hollywood requested renewal of its Casino Owner's License and submitted payment of the annual renewal fee.

On March 20, 2014, by Order 2014-53, the Commission renewed a written power of attorney identifying Larry Kinser as trustee-in-waiting for Hollywood. Order 2014-53 stated that the power of attorney would expire "upon the effectiveness of a subsequent Commission order that either: (1) addresses the renewal of Hollywood's Casino Owner's License; or (2) modifies or withdraws the approval" of Mr. Kinser. On October 13, 2014, Hollywood indicated in writing that it desires to continue to have Mr. Kinser as trustee-in-waiting.

## **COMMISSION ACTION**

Pursuant to IC 4-33-6-12, the Commission finds that Hollywood has substantially complied with the directives of IC 4-33 and Title 68 of the Indiana Administrative Code and is suitable to hold a Casino Owner's License. The Commission **GRANTS** renewal of Hollywood's Casino Owner's License for a period of one year subject to Hollywood maintaining its casino gambling operation, riverboat, hotel, and pavilion in substantial compliance with all properly applicable state and local laws, including but not limited to, Commission regulations, resolutions, orders and/or other directives relating to the Casino Owner's License, or to the lawful operation or conduct of gaming in Indiana. The renewal of the Casino Owner's License is valid for a period of one year from December 10, 2014 through December 9, 2015.

Furthermore, the Commission <u>GRANTS</u> renewal of its approval of the written power of attorney identifying Larry Kinser as trustee-in-waiting for Hollywood. The renewal of the Commission's approval expires upon the effectiveness of a subsequent Commission order that either: (1) addresses the renewal of Hollywood's Casino Owner's License; or (2) modifies or withdraws the renewal of its approval as granted herein.

According to IC 4-21.5-3, this order is effective fifteen (15) days after the order is served.
