

ORDER 2020-94
AN ORDER OF THE INDIANA GAMING COMMISSION
CONCERNING RENEWAL OF SUPPLIER'S LICENSES

In accordance with Ind. Code art. 4-33, Ind. Code art. 4-35, and 68 Ind. Admin. Code § 2-2, the Indiana Gaming Commission ("Commission") previously issued supplier's licenses to: (1) NYX Digital Gaming (USA), LLC (temporary license); (2) Gaming Partners International USA, Inc.; (3) Sportradar Solutions, LLC (temporary license); (4) Everi Games, Inc.; (5) GLP Capital, LP; (6) Surveillance Systems Integration, Inc. (temporary license); (7) GAN (UK) Limited (temporary license); (8) SBTech Malta Limited (temporary license); (9) United Tote Company (temporary license); (10) Aristocrat Technologies, Inc. (11) American Gaming Systems, LLC.

A supplier's license is valid for a period of one year. Further, in accordance with Ind. Code § 4-33-7-8, a supplier's license must be renewed annually along with the payment of Seven Thousand Five Hundred Dollars (\$7,500.00) as an annual renewal fee. Each of these licensees has requested renewal and paid the required renewal fee. The Commission has determined that the above-named supplier licensees remain in substantial compliance with Ind. Code art. 4-33, Ind. Code art. 4-35, and Title 68 of the Indiana Administrative Code and are suitable to hold a supplier's license.

The Commission hereby **GRANTS** the renewal of the licenses of each of the following for a period of one year as specified below:

- 1) NYX Digital Gaming (USA), LLC: valid August 7, 2020 through August 6, 2021;
- 2) Gaming Partners International USA, Inc.: valid August 19, 2020 through August 18, 2021;
- 3) Sportradar Solutions, LLC: valid August 21, 2020 through August 20, 2021;
- 4) Everi Games, Inc.: valid September 15, 2020 through September 14, 2021;
- 5) GLP Capital, LP: valid September 19, 2020 through September 18, 2021;
- 6) Surveillance Systems Integration, Inc.: valid September 23, 2020 through September 22, 2021;
- 7) GAN (UK) Limited: valid October 15, 2020 through October 14, 2021;
- 8) SBTech Malta Limited: valid October 22, 2020 through October 21, 2021;
- 9) United Tote Company: valid November 4, 2020 through November 3, 2021;
- 10) Aristocrat Technologies, Inc.: valid November 9, 2020 through November 8, 2021;
- 11) American Gaming Systems, LLC: valid November 12, 2020 through November 11, 2021.

Each licensee must notify the Commission of its desire to be considered for subsequent license renewal at least thirty days before the expiration of the license.
