

ORDER 2021-129
AN ORDER OF THE INDIANA GAMING COMMISSION
CONCERNING RENEWAL OF SUPPLIER'S LICENSES

In accordance with Ind. Code art. 4-33, Ind. Code art. 4-35, and 68 Ind. Admin Code § 2-2, the Indiana Gaming Commission ("Commission") previously issued supplier's licenses to: (1) Kambi Group PLC; (2) GeoComply Solutions, Inc.; (3) Hard Rock Gary Manager, LLC; (4) Gaming Partners International USA, Inc.; (5) Neogames Solutions LLC; (6) Everi Games, Inc.; and (7) GLP Capital, L.P. The Commission previously issued temporary supplier's licenses to: (1) Galaxy Gaming, Inc.; and (2) NYX Digital Gaming (USA) LLC.

A supplier's license is valid for a period of one year. Further, in accordance with Ind. Code § 4-33-7-8, a supplier's license must be renewed annually along with the payment of Seven Thousand Five Hundred Dollars (\$7,500.00) as an annual renewal fee. Each of these licenses has requested renewal and paid the required renewal fee. The Commission has determined that the above-named supplier licensees remain in substantial compliance with Ind. Code art 4-33, Ind. Code art. 4-35, and Title 68 of the Indiana Administrative Code and are suitable to hold a supplier's license.

The Commission hereby **GRANTS** the renewal of the licenses of each of the following for a period of one year as specified below:

- (1) Kambi Group PLC: valid July 10, 2021 through July 9, 2022;
- (2) GeoComply Solutions, Inc.: valid July 10, 2021 through July 9, 2022;
- (3) Hard Rock Gary Manager, LLC: valid July 10, 2021 through July 9, 2022;
- (4) Gaming Partners International USA, Inc.: valid August 19, 2021 through August 18, 2022;
- (5) Neogames Solutions LLC: valid September 11, 2021 through September 10, 2022;
- (6) Everi Games, Inc.: valid September 15, 2021 through September 14, 2022;
- (7) GLP Capital, L.P.: valid September 19, 2021 through September 18, 2022.

The Commission hereby **GRANTS** the renewal of the temporary license of each of the following for a period of one year as specified below:


- (1) Galaxy Gaming, Inc.: valid August 4, 2021 through August 3, 2022;
- (2) NYX Digital Gaming (USA) LLC: valid August 6, 2021 through August 5, 2022.

Each licensee must notify the Commission of its desire to be considered for subsequent license renewal at least thirty days before the expiration of the license.


