

ORDER 2021-133
AN ORDER OF THE INDIANA GAMING COMMISSION
CONCERNING RENEWAL OF CERTIFICATES OF AUTHORITY

In accordance with Ind. Code art. 4-38 and Title 68 of the Ind. Admin. Code, the Indiana Gaming Commission (“Commission”) previously issued Certificates of Authority to: (1) Ameristar Casino East Chicago, LLC; (2) Centaur Acquisition, LLC d/b/a Caesars Sportsbook at Indiana Grand; (3) Indiana Gaming Company, LLC d/b/a Hollywood Casino; (4) Hoosier Park, LLC d/b/a Caesars Race and Sportsbook, Indianapolis; (5) Horseshoe Hammond, LLC; (6) Blue Chip Casino, LLC; (7) Blue Sky Casino, LLC d/b/a French Lick Resort; (8) Belterra Resort Indiana, LLC; (9) Aztar Indiana Gaming Company, LLC d/b/a Tropicana Evansville; (10) Caesars Riverboat Casino, LLC d/b/a Caesars Southern Casino; (11) Centaur Acquisition, LLC d/b/a Caesars Race and Sportsbook, Clarksville (12) Hoosier Park, LLC d/b/a Caesars Sportsbook at Hoosier Park; (13) Hoosier Park, LLC d/b/a Caesars Race and Sportsbook, New Haven.

A certificate of authority is valid for a period of one year. Further, in accordance with Ind. Code § 4-38-8-1, a certificate of authority must be renewed annually along with the payment of Fifty Thousand Dollars (\$50,000.00) as an annual administrative due on the anniversary of the date that certificate holders commenced sports wagering operations. Each of these certificate holders has requested renewal and paid the required administrative fee. The Commission has determined that the above-named certificate holders remain in substantial compliance with Ind. Code art. 4-33, Ind. Code art. 4-38, and Title 68 of the Indiana Administrative Code and are suitable to hold a certificate of authority. On August 30, 2021, pursuant to a delegation of authority granted by the Commission in Resolution 2019-257, the Executive Director extended the license through a date when the Commission could consider these renewal requests.


The Commission hereby **GRANTS** the renewal of the licenses of each of the following for a period of one year as specified below:

- 1) Ameristar Casino East Chicago, LLC: valid September 1, 2021 through August 31, 2022;
- 2) Centaur Acquisition, LLC d/b/a Caesars Sportsbook at Indiana Grand: valid September 1, 2021 through August 31, 2022;
- 3) Indiana Gaming Company, LLC d/b/a Hollywood Casino: valid September 1, 2021 through August 31, 2022;
- 4) Hoosier Park, LLC d/b/a Caesars Race and Sportsbook, Indianapolis: valid September 3, 2021 through September 2, 2022;
- 5) Horseshoe Hammond, LLC: valid September 4, 2021 through September 3, 2022;
- 6) Blue Chip Casino, LLC: valid September 5, 2021 through September 4, 2022;
- 7) Blue Sky Casino, LLC d/b/a French Lick Resort: valid September 6, 2021 through September 5, 2022;
- 8) Belterra Resort Indiana, LLC: valid September 9, 2021 through September 8, 2022;
- 9) Aztar Indiana Gaming Company, LLC d/b/a Tropicana Evansville: valid September 12, 2021 through September 11, 2022;
- 10) Caesars Riverboat Casino, LLC d/b/a Caesars Southern Casino: valid September 12, 2021 through September 11, 2022;
- 11) Centaur Acquisition, LLC d/b/a Caesars Race and Sportsbook, Clarksville: valid September 12, 2021 through September 11, 2022;
- 12) Hoosier Park, LLC d/b/a Caesars Sportsbook at Hoosier Park: valid September 19, 2021 through September 18, 2022;
- 13) Hoosier Park, LLC d/b/a Caesars Race and Sportsbook, New Haven: valid September 19, 2021 through September 18, 2022.


Each certificate holder must notify the Commission of its desire to be considered for subsequent certificate renewal at least thirty days before the expiration of the license.
