ORDER 2021-206

AN ORDER OF THE INDIANA GAMING COMMISSION RENEWING THE CASINO OWNER'S LICENSE AND WRITTEN POWER OF ATTORNEY FOR BELTERRA RESORT INDIANA, LLC

In accordance with Ind. Code art. 4-33 and Title 68 of the Indiana Administrative Code, the Indiana Gaming Commission ("Commission") issued a casino owner's license to Belterra Resort Indiana, LLC ("Belterra"), effective October 23, 2000. The Commission has renewed the license annually since inception, most recently on November 23, 2020, which renewed the license through October 22, 2021. On June 28, 2018, by Order 2018-121, the Commission approved the application for transfer of ownership interest for Belterra from Pinnacle Entertainment, Inc. to Boyd Gaming Corporation ("Boyd"); however, Belterra retained the casino owner's license.

On October 19, 2021, Belterra requested renewal of its casino owner's license and submitted payment of the annual renewal fee in the amount of \$5,000. On October 20, 2021, pursuant to a delegation of authority granted by the Commission in Resolution 2019-257, the Executive Director extended the license through a date when the Commission could consider Belterra's request.

On August 18, 2020, by Order 2021-120, the Commission approved the modification of the power of attorney naming Ellis Landau as trustee-in-waiting for Belterra. Order 2021-120 stated this approval would expire "upon effectiveness of a subsequent Commission order that either: (1) addresses the renewal of Belterra's casino owner's license; or (2) modifies or withdraws the approval" of Mr. Landau. On October 19, 2021, Belterra indicated in writing that it desired to continue to have Mr. Landau as its trustee-in-waiting.

COMMISSION ACTION

Pursuant to Ind. Code § 4-33-6-12, the Commission has found that Belterra has substantially complied with the directives of Ind. Code art. 4-33 and Title 68 of the Indiana Administrative Code; therefore, Belterra is suitable to hold a casino owner's license. The Commission **GRANTS** renewal of Belterra's casino owner's license for a period of one year subject to Belterra maintaining its casino gambling operation, riverboat, hotel, and pavilion in substantial compliance with all applicable state and local laws including, but not limited to, Commission regulations, resolutions, orders, and/or other directives relating to the casino owner's license, or the lawful operation or conduct of gaming in Indiana. The renewal of the casino owner's license is valid for a period of one year from October 23, 2021 through October 22, 2022.

Furthermore, the Commission **APPROVES** the renewal of the power of attorney identifying Ellis Landau as trustee-in-waiting for Belterra. The renewal expires upon the effectiveness of a subsequent Commission order that either: (1) addresses the renewal of Belterra's casino owner's license; or (2) modifies or withdraws the renewal of the power of attorney approved herein.

According to Ind. Code ch. 4-21.5-3, this Order is effective fifteen days after it is served.
