

ORDER 2022-61
AN ORDER OF THE INDIANA GAMING COMMISSION
CONCERNING RENEWAL OF SUPPLIER'S LICENSES

In accordance with Ind. Code art. 4-33, 4-35, 4-38 and 68 Ind. Admin. Code § 2-2, the Indiana Gaming Commission ("Commission") previously issued supplier's licenses to: (1) Surveillance System Integration; (2) Power Strategies LLC; (3) Bally's Interactive, LLC.; (4) White Hat Gaming; (5) Konami Gaming, Inc.; (6) Masque Publishing, Inc.; (7) Everi Payments, Inc.; (8) Ainsworth Game Technology; (9) United States Playing Card Company; (10) House Advantage, LLC.; (11) Novomatic America Sales, LLC; (12) NRT Technology Corp; (13) Pala Interactive; (14) VICI Properties, Inc. (POA); (15) Kambi (Sports Information Services Limited); (16) Geocomply Solutions, Inc.

A supplier's license is valid for a period of one year. Further, in accordance with Ind. Code § 4-33-7-8, a supplier's license must be renewed annually along with the payment of Seven Thousand Five Hundred Dollars (\$7,500.00) as an annual renewal fee. Each of these licensees has requested renewal and paid the required renewal fee. The Commission has determined that the above-named supplier licensees remain in substantial compliance with Ind. Code art. 4-33, 4-35, 4-38 and Title 68 of the Indiana Administrative Code and are suitable to hold a supplier's license.


The Commission hereby **GRANTS** the renewal of the licenses of each of the following for a period of one year as specified below:

- 1) Surveillance System Integration: valid March 23, 2022 through March 22, 2023;
- 2) Power Strategies LLC: valid May 18, 2022 through May 17, 2023;
- 3) Bally's Interactive, LLC.: valid May 24, 2022 through May 23, 2023;
- 4) White Hat Gaming: valid May 24, 2022 through May 23, 2023;
- 5) Konami Gaming, Inc.: valid May 28, 2022 through May 27, 2023;
- 6) Masque Publishing, Inc.: valid May 29, 2022 through May 28, 2023;
- 7) Everi Payments, Inc.: valid June 1, 2022 through May 31, 2023;
- 8) Ainsworth Game Technology: valid June 16, 2022 through June 15, 2023;
- 9) United States Playing Card Company: valid June 16, 2022 through June 15, 2023;
- 10) House Advantage, LLC: valid June 17, 2022 through June 16, 2023;
- 11) Novomatic America Sales, LLC: valid June 17, 2022 through June 16, 2023;
- 12) NRT Technology Corp.: valid June 22, 2022 through June 21, 2023;
- 13) Pala Interactive: valid June 26, 2022 through June 25, 2023;
- 14) VICI Properties, Inc. (POA): valid June 28, 2022 through June 27, 2023;
- 15) Kambi (Sports Information Services Limited): valid July 9, 2022 through July 8, 2023; and
- 16) Geocomply Solutions, Inc.: valid July 9, 2022 through July 8, 2023.

Each licensee must notify the Commission of its desire to be considered for subsequent license renewal at least thirty days before the expiration of the license.


